Order, 1956.

An Act to facilitate the activity in connection with the Bhudan Yagna initiated by Shri Acharya Vinoba Bhave and to provide for the constitution of a Bhudan Yagna Board, the donation of lands to the said Board, the distribution of lands received in donation to ²[landless persons and for community purposes] and to provide for matters ancillary thereto.

WHEREAS, it is expedient to facilitate the activity in connection with the Preamble. Bhudan Yagna initiated by Shri Acharya Vinoba Bhave and to provide for the constitution of a Bhudan Yagna Board, the donation of lands to the said Board, the distribution of lands received in donation to Ilandless persons and for community purposes] and to provide for matters ancillary thereto;

It is hereby enacted as follows:-

CHAPTER I-PRELIMINARY

- 1. (1) This Act may be cited as the Madhya Pradesh Bhudan Yagna Act, Short title and extent.
 - (2) It extends to the whole of ³[Vidarbha Region of the State of Maharashtra].

Definitions.

- 2. In this Act, unless there is anything repugnant in the subject or context,—
- '[(a) "Bhudan holder" means a person recorded in village papers or recordof-rights as a Bhudan holder under section 24;]
- *[(a-I)] "Bhudan Yagna" means the movement initiated by Shri Acharya Vinoba Bhave for the acquisition of lands through voluntary gifts in favour of the Board:
 - (b) "Board" means the Bhudan Yagna Board established under section 3;
- [(b-1) "Community purpose" means any purpose which is for the good of the comminity of the village in general;]
- (c) "land" means land which is occupied or let for agricultural purposes or for purposes subservient to agriculture or for pasture;
- (d) "landless person" means a person holding no land or land less than the area which may be prescribed in this behalf;
- (e) "Revenue Officer" in any provision of this Act means such Revenue Officer appointed under ²[the Central Provinces Land Revenue Act, 1917, or the Berar Land Revenue Code, 1928], as the case may be, as the State Government may, by notification, direct to discharge the functions of a Revenue Officer under
 - (f) "prescribed" means prescribed by rules made under this Act.

CHPTER II—ESTABLISHMENT OF THE BOARD

Incorpora-3. (1) There shall be established a Board by the name of the Madhaya Pradesh tion of Bhudan Yagna Board. Yagna

(2) The Board shall be a body corporate having perpetual succession and Board. common seal with power to acquire and dispose of property both movable and immovable and shall, by the said name, sue and be sued.

(3) It shall be the duty of the Board to administer all land vested in it for the benefit of the Bhudan Yagna in accordance with the provisions of this Act.

Constitution of Board.

- 4. The Board shall consist of the following, namely:
- (a) the Chairman—to be nominated by Shri Acharya Vinoba Bhave; and (b) six or more, but not exceeding ten members to be nominated by Shri Acharya Vinoba Bhave.

Appointment ³[4A. (1) One of the members shall be appointed as the Secretary of the of Secretary. Board by Shri Acharya Vinoba Bhave.

- (2) The Board may delegate any of its powers and functions under the Act except the power to make regulations under section 34 to the Secretary or any member or to a sub-committee of three or more of its members.].

- (2) Any vacancy of a ²[Chairman, Secretary] or a member shall be filled as early as practicable.

- 9. The remuneration and other conditions of service of the officers and servants Conditions of the Board shall be such as may be determined by regulations.

- 10. The Board shall meet and shall, from time to time, make such arrange-Conduct of ments with respect to the day, time, notice, management and adjournment of its business. meetings as it thinks fit, subject to the following provisions, namely:—
 - (a) the Chairman may, whenever he thinks fit, call special meetings;
 - (b) every meeting shall be presided over by the Chairman and, in his absence, by any member chosen by the meeting to preside for the occasion;
 - (c) all questions at any meeting shall be decided by a majority of the members present and, in case of equality of votes, the person presiding shall have and exercise a second or casting vote; and
 - (d) the minutes of the proceedings of each meeting shall be recorded in a book to be provided for the purpose.
 - 11. (1) The quorum for the meeting shall be of five members. Quorum.
- (2) If at any meeting of the Board a quorum is not present the Chairman shall adjourn the meeting to such other day as he may think fit, and the business, which would have been brought before the original meeting, if there had been a quorum present, shall be brought before, and transacted at, the adjouned meeting, whether there is a quorum present there at or not.
- 12. The Board shall have its own fund, and may accept grants, donations, Board's gifts or loans from the Central or the State Governments or local authority or any funds. individual or body, whether incorporated or not, for all or any of the purposes of the Board.
- 13. All property, fund and all other assets vesting in the Board shall be held Application and applied by it, subject to the provisions and for the purposes of this Act. of funds.
- 14. The Board may enter in to and perform all such contracts as it may consider Power to necessary or expedient for carrying out any of the purposes of this Act.

- **Dissolution** [15. (1) Shri Acharya Vinoba Bhave may at any time, without assigning of Board any reason, by a written order, dissolve the Board and reconsititute the Board in accordance with the provisions of this Act.
 - (2) The order dissolving the Board shall be notified in the Gazette and shall take effect on the date on which it is so notified].
- Tahsil 16. (1) The Board may, for any tahsil or taluk where it considers necessary so to do, constitute Tahsil Committees consisting of not less than three and not more than seven members to be appointed by the Board *[.....]

CHAPTER III—DONATIONS OF LAND

Procedure 17. (1) Any person owning a transferable interest in land and desiring to make for making donation of a gift thereof to the Board may submit 4[a declaration making the offer] in the presland cribed form to the Board.

- (2) The Board shall, if it considers the gift acceptable, forward the [declaration] to the Revenue Officer having jurisdiction in the tahsil or taluq where the land is
- (3) On receipt of the 5[declaration] mentioned in sub-section (1), the Revenue Officer snall, if satisfied, after such summary inquiry as he thinks necessary, that the donor is competent to make the gift and has valid title in the land, issue a notice in the prescribed form to all such persons as he may consider interested in the property calling upon them, before a date specified in the notice, to show cause why the gift should not be accepted.
- (4) The Revenue Officer shall also affix a copy of the notice referred to in subsection (3) on the notice-board of his court and shall cause it to be published by beat of drum in the village where the land is situate.
- (5) Any person interested in the property may, before the date specified in the notice, file an objection before the Revenue Officer showing cause why the gift
 - (6) All such objections shall be inquired into and decided by the Revenue Officer.
- (7) If no objection is filed before the specified date, or if all the objections filed have been rejected by the Revenue Officer, he shall pass an order accepting the
- (8) On the acceptance of the gift, all title and interest of the donor in the land shall be extinguished and the land shall, subject to the provisions of section 18, vest in the Board in the same rights in which it was held by the donor.

- (9) The order made under sub-section (7) shall be got registered under the Indian of Registration Act, 1908, by the Revenue Officer in such manner as may be pres-1908. cribed and it shall then take effect from the date of the order, as if it were a deed of gift.
 - (10) No fee for registration of the order shall be chargeable.
 - (11) The Revenue Officer may at any stage of the proceedings reject the '[offer] of the donor on any of the following grounds, namely:—
 - (i) that the donor is incompetent to make the gift;
 - (ii) that the title of the donor is defective;
 - (iii) that there are encumbrances on the land;
 - •[(iv)];

- (v) such other grounds as may be prescribed.
- 18. The order of the Revenue Officer, rejecting an objection passed under sub-section Order of (7) of section 17, shall not be subject to appeal or revision but any party aggrieved Revenue by the order or any other person interested in the land who had no notice of the officer proceedings under section 17 may within six months from the data of each in subject of proceedings under section 17 may, within six months from the date of such order, civil suit. institute a suit in the Civil Court having jurisdiction to have the order set aside and the decision of such Court shall be binding on the Board, and subject to the result of such suit, if any, the order of the Revenue Officer shall be conclusive,
- 19. Every gift of land in respect of which an order has been passed under section Gifts to be 17 shall, after the date of the order, be irrevocable.
- 20. The lands vesting in the Board shall not be liable to attachment or sale in Lands execution of any decree or order passed by a Civil Court against the Board. vesting in Board not attachable.
- 21. (1) Where any land has been donated for purposes of the Bhudan Yagna Donation S[before the coming in to force of the Madhya Pardesh Bhudan Yagna (Amendment) of land prior xxI Act. 1954], the Board shall prepare a list of all such lands showing thereincement of Act. 1954.
 - (a) The area and description;
 - (b) the name of the donor;
 - (c) the nature of the interest of the donor in the land:
 - (d) if the land has been granted to any person in pursuance of the Bhudan Yagna, the name of the person to whom the land has been granted;
 - (e) the date of the grant under clause (d); and
 - (f) such other particulars as may be prescribed.
 - (2) The list so prepared shall be forwarded to the Deputy Commissioner of the district within whose jurisdiction the land is situate.
 - (3) On receipt of such list, the Deputy Commissioner shall cause action to be taken in accordance with section 17 in respect of the lands described in the list.

- (4) The provisions of '[sections 17 to 20 and 21-A] shall apply in respect of all the donations of the said lands as they apply in respect of all donations of lands made after the commencement of this Act:

Provided that where an order is made by a Revenue Officer under sub-section (7) of section 17, the gift shall be deemed to have been accepted with effect from the date on which the donation of land was made and for this purpose this Act shall be deemed to have been in force on such date.

(5) If any land of which the donation so received before the commencement of this Act has already been granted to any person in pursuance of the Bhudan Yagna, it shall be deemed to have been granted by the Board to such person on the date on which such person takes possession thereof and the grant shall be subject to all liabilities to which any grants made by the Board in general shall be subject.

CHAPTER IV—DISTRIBUTION OF LAND

Power of Board to leases.

- 22. Notwithstanding anything provided in any law to the contrary,
 - (i) the Board shall have power to 3[allot] the land vesting in it; and
- (ii) the 3[allottee] shall not have and shall not be entitled to claim any rights except as provided for in this Act.
- 23. The Tahsil Committee shall, in accordance with such regulations as may Tahsil Committee be made by the Board in this behalf, distribute the land vesting in the Board to to distribute be made by the Board in this bolinary, land, landless persons who are capable of cultivating the same personally.

CHAPTER V—MISCELLANEOUS

- 28. The acceptance of a gift under section 17 or a grant of land made or deemed Exemption to be made under the provisions of this Act, shall be and be deemed always to have from stamp duty and been exempt from payment of stamp duty and from registration or attestation under registration. the law relating to registration and execution of documents, any law to the contrary notwithstanding.
- 29. Any person in possession of the land on the date of the order passed under Ejectment of section 17 and any person who takes possession, otherwise than in accordance persons unwith law, of 3[the land received in donation for purposes of the Bhudan Yagna] possession, may, on an application to a Revenue Officer by the Board or the 4[Bhudan holder] concerned be ejected.

Procedure.

32. The proceedings under this Act shall be deemed for all purposes to be proceedings under '[the Central Provinces Land Revenue Act, 1917, or the Berar II of Land Revenue Code, 1928], as the case may be, and the procedure applicable to 1917. proceedings under the said Act, or the Code shall be followed.

Board's power to act as Tahsil Committee.

33. If no Tahsil Committee has been formed for any tahsil or taluq, the functions of a Tahsil Committee under this Act, shall be performed by the Board.

Construction

Power of Board to allot land for community purpose.

- 35B. (1) The Board may allot any land vesting in it for a community purpose or exchange any such land with other land or surrender it to the State Government.
- (2) The land allotted for a community purpose shall vest in the State Government from the date of such allotment].

Regulations.

- 34. The Board may, from time to time, with the previous sanction of the State Government, make regulations consistent with this Act and any rules made there-
 - (a) for regulating its procedure and the disposal of its business;
 - (b) for the remuneration and conditions of service of its employees;
- ³[(c) for regulating the procedure, disposal of business, constitution and supersession of Tahsil Committees, the term of office and the filling of casual vacancies of office-bearers and members of such committees and removal of office-bearers
 - (d) for the principles to be followed for the distribution of lands, qualifications of persons to whom lands may be given and the maximum area to be 4[allotted]
 - ⁵[(e) for the appointment of the sub-committees and for the delegation of powers to sub-committees and office-bearers and individual members thereof;]
 - (f) for any other matter arising out of Board's funcition under this Act for which it is necessary or expedient to make regulations.

- 35. (1) The State Government may, by notification and subject to the condition Power to make rules of previous publication, make rules to carry out the purposes of this Act.
- (2) In particular, and without prejudice to the generality of the foregoing power, the State Government may make rules,—
 - (a) prescribing the area of land for purposes of clause (d) of section 2;
 - (b) prescribing the form of '[declaration] under sub-section (1) of section 17 for submitting '[a declaration] to make a gift of land;
 - (c) prescribing the form of notice under sub-section (3) of section 17 calling upon persons to show cause why a gift of land should not be accepted;
 - (d) prescribing the manner of registering an order accepting a gift, under sub-section (9) of section 17;
 - (e) stating other grounds under item (v) of sub-section (11) of section 17 for rejecting ²[the offer] to make a gift; and
 - (f) prescribing other particulars under clause (f) of sub-section (1) of section 21.
